Introduction. BIM Execution Plan is a constitutional rule-book for the project covering all topics required for execution of the project. No collaborative BIM activities involving more than one stakeholder could be performed without agreement on BEP document. The BEP author should discuss terms of services with relevant stakeholders prior to the development of the document.

A BIM Execution Plan (BEP) is a document that sets out how information on a project will be managed to ensure interoperability between all parties and the delivery of the client's goals for the project. Where a project is privately procured, the client may or may not formally request a BIM Execution Plan.
