The 2010, 2013, 2016 and 2019 California Fire Code (CFC) also require control valves in buildings where the floor level of the highest story is located more than 30 feet above the lowest level of fire department vehicle access, when a building is four or more stories in height or when a building is two or more stories below the highest level of fire department vehicle access.
