Label the page Works Cited (do not italicize the words Works Cited or put them in quotation marks) and center the words Works Cited at the top of the page. Only the title should be centered. The citation entries themselves should be aligned with the left margin. Double space all citations, but do not skip spaces between entries.

Like the rest of an MLA format paper, the Works Cited should be left-aligned and double-spaced with 1-inch margins. MLA Works Cited | Elements, Examples & Templates

Well, new MLA standards require writing a citation for the editors (1, above), and a citation for each of the separate entries. In this situation, the citation for the individual entry is a bit shorter than if you were only listing one story from the anthology (2, above).
