On 28th August 1833 a very important act received its Royal Assent. The Slavery Abolition Law would finally be enacted, after years of campaigning, suffering and injustice. This act was a crucial step in a much wider and ongoing process designed to bring an end to the slave trade. Only a few decades previously, in 1807 another act had been passed which had made it illegal to purchase slaves directly from the African continent.
