DSimeonova Negative Effects of Securitizing Immigration

The above securitization discourse that started in the 1980s also led to a change in policy from Western Europe to Canada and Australia: Western states have been systematically making the movement of migrants and refugees harder through visa restrictions, mandatory detention, return policies, international "safe havens", offshore processing, "safe third country agreements and declarations", withdrawal of benefits etc. (see Watson, 2009, Chapter 1).
