The certifying physician would still be required to certify that a face-to-face patient encounter occurred and document the date of the encounter as part of the certification of eligibility.

If narrative is an addendum, the physician also must sign immediately following narrative in addendum For recertification narratives associated with the third or later benefit period, there must be an explanation stating why the clinical findings of the face-to-face encounter support a life expectancy of 6 months or less
